FITZ FLAG (ARG) had no speed and settled inside, commenced a bid two wide, angled to the rail into the stretch and was slowly gaining. UFFIZI also was outrun for six furlongs, was roused two wide leaving the three eighths then also was making up ground late but did not threaten the winner. FIRE WOOD trailed to the far turn the second turn, got fanned four wide while trying to rally to the stretch and made up ground belatedly. AMAZIN BLUE was allowed to settle, came three wide to the stretch then finished evenly. WE BROTHERS prompted the pace for six furlongs, stopped after a mile then was eased in the stretch but walked off.
