



THE ARLINGTON MILLION XXXVII – GRADE I

(37th Running)



To Be Run: Saturday, August 10, 2019

FOR THREE-YEAR-OLDS AND UPWARD. WEIGHT-FOR-AGE. By subscription of \$300 (each horse) if made on or before Saturday, May 18, 2019, with the fee to accompany the nomination. Late nominations of \$2,000 (each horse) on or before Saturday, July 27, 2019. The entry and starting fees for the ARLINGTON MILLION XXXVII (GI) will be waived for any horse that finishes 1st, 2nd or 3rd in the ARLINGTON HANDICAP (GIII) on Saturday, July 13th which enters and starts in the ARLINGTON MILLION XXXVII (GI) on Saturday, August 10, 2019. A Supplementary Nomination of \$40,000 may be made by 12:00pm (CDT) on Friday, August 2, 2019, which includes entry and starting fees. (A refund of \$35,000 will be made to any Supplementary Nominee that fails to make the starting field or upon production of a veterinarian certificate indicating the horse is not fit to run.) **Owners and/or trainers of nominated horses will be required to contact officials of ARLINGTON INTERNATIONAL RACECOURSE or officials of the INTERNATIONAL RACING BUREAU to pre-enter their horse(s) and name a jockey by 12:00pm (CDT) on Friday, August 2, 2019, along with the payment of the \$5,000 Entry Fee and \$10,000 Starting Fee,** which will only be refunded upon production of a veterinarian certificate indicating the horse is not fit to run or fails to draw into the starting field. \$1,000,000 GUARANTEED, of which 1% of the guaranteed purse shall be paid to the owners of the horses finishing seventh through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. WEIGHT-FOR-AGE: NORTHERN HEMISPHERE: Three-Year-Olds, 120 lbs.; Fillies, 117 lbs.; Four-Year-Olds and Older, 126 lbs.; Fillies and Mares, 123 lbs. SOUTHERN HEMISPHERE: Three-Year-Olds, 115 lbs.; Fillies, 111 lbs.; Four-Year-Olds, 122 lbs.; Four-Year-Old Fillies, 118 lbs.; Older, 126 lbs.; Mares, 123 lbs.

The 2019 MUNIZ MEMORIAL HANDICAP (GII) winner at Fair Grounds Race Course will be granted an automatic berth (no fees) to the 2019 OLD FORESTER TURF CLASSIC (GI) May 5th at Churchill Downs and the 2019 ARLINGTON MILLION XXXVII (GI) August 10th. The winner of the 2019 OLD FORESTER TURF CLASSIC (GI) at Churchill Downs will also be granted an automatic berth (no fees) to the ARLINGTON MILLION XXXVII (GI).

The ARLINGTON MILLION XXXVII (GI) has been selected as one of the Breeders' Cup "Win and You're In" Challenge Races. The nominated winner of the ARLINGTON MILLION XXXVII (GI) will be entitled to automatic entry into the 2019 running of the BREEDERS' CUP TURF (GI), nominated winner will be entitled to have pre-entry and entry fees waived for the BREEDERS' CUP TURF (GI) or will receive a credit equal to the BREEDERS' CUP TURF (GI) pre-entry and entry fee amount towards any other Breeders' Cup Championship race, and all horses will be entitled to receive a travel stipend if traveling from a base located outside the state of California. To be eligible for the 2019 Breeders' Cup World Championships held at Santa Anita on November 1 and 2, 2019, all horses must be pre-entered by noon (local standard time at the designated place of pre-entry) on Monday, October 21, 2019. Winner must be nominated by pre-entry deadline to receive Challenge rewards.

In the event a designated Breeders' Cup Challenge turf race (Turf Sprint, Juvenile Turf Sprint, Juvenile Turf, Juvenile Fillies Turf, Filly and Mare Turf Division, Turf Division or Mile Division) is taken off the turf, due to unsafe racing conditions, the horse that wins the "off the turf" race will NOT receive an automatic qualifying position and will NOT receive the starting fees (the total of pre-entry and entry fees) to enter the Breeders' Cup World Championships in the applicable Turf Division race; provided, however, that Breeders' Cup Limited may, at its option, reinstate the "Win and You're In" status of the "off the turf" race. The decision to take a Breeders' Cup Challenge Division turf race off the turf course is under the sole discretion of the racetrack/racing association, not Breeders' Cup Limited.

All Challenge winners are subject to out-of-competition testing. All runners are subject to out-of-competition testing by the CHRC and/or BCL.

Breeders' Cup Limited reserves the right in its sole discretion to postpone, discontinue, amend or change the conditions of all or any part of the Breeders' Cup Challenge "Win & You're In" race program.



The winner of the 2019 ARLINGTON MILLION XXXVII (GI) will be invited to the 2019 JAPAN CUP (GI) to be run on Sunday, November 24th. Under the 2019 JAPAN CUP (GI) bonus program, should the winner of the 2019 ARLINGTON MILLION XXXVII (GI) successfully win the 2019 JAPAN CUP (GI), the prize money for the winner will be 300,000,000 JPY (approximately \$2,600,000USD, if 115 JPY = \$1USD) and will also receive a bonus of \$1,000,000USD. Should the winner of the 2019 ARLINGTON MILLION XXXVII (GI) finish 2nd the bonus will be \$400,000USD; 3rd, \$250,000USD; 4th to last, \$100,000USD.

The winner of the Group II PREMIO PRESIDENTE DELLA REPUBBLICA at Capannelle (May 19th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I PRIX D'ISPAHAN at Longchamp (May 26th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I TATTERSALLS GOLD CUP at The Curragh (May 26th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I CORAL-ECLIPSE at Sandown Park (July 13th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I GROSSER DALLMAYR-PREIS-BAYERISCHES ZUCHTRENKEN at Munich (July 28th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winners of the Group II PREMIO PRESIDENTE DELLA REPUBBLICA, Group I PRIX D'ISPAHAN, Group I TATTERSALLS GOLD CUP, Group I CORAL-ECLIPSE AND Group I GROSSER DALLMAYR-PREIS-BAYERISCHES ZUCHTRENKEN must be either: an Early Nominee for the 2019 ARLINGTON MILLION XXXVII (GI) - \$300 on Saturday, May 18th or a Late Nomination - \$2,000 on Saturday, July 27th.

One Mile and One Quarter (On The Turf)

This event will be limited to fourteen (14) starters ([7] North American starters and [7] Non-North American starters.) Preference will be given in the following order: (1st) Grade/Group I winners in 2019; (2nd) Grade/Group II winners in 2019; (3rd) Grade/Group III winners in 2019. (Total Earnings in 2019 will be used in determining the order of preference of horses with equal Grade/Group winners.) Horses that have not won a Grade/Group race in 2019, preference will be Total Lifetime Earnings. Failure to draw into this race at time of entry cancels all fees with the exception of the nominating fee(s).

HORSES MUST BE PRE-ENTERED WITH A JOCKEY BY 12:00PM (CDT) ON FRIDAY, AUGUST 2ND ALONG WITH THE PAYMENT OF THE ENTRY AND STARTING FEES; STARTERS TO BE NAMED THROUGH THE ENTRY BOX ON TUESDAY, AUGUST 6, 2019. Two (2) horses having common ties through ownership cannot start to the exclusion of a single-ownership interest. The winning owner, trainer and jockey will receive a trophy from ARLINGTON INTERNATIONAL RACECOURSE.

In the event this stakes race is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee.

CONDITIONS FOR THE 2019 ARLINGTON MILLION XXXVII (GI)

The entry and starting fees for the ARLINGTON MILLION XXXVII (GI) will be waived for any horse that finishes 1st, 2nd or 3rd in the ARLINGTON HANDICAP (GIII) on Saturday, July 13th which enters and starts in the ARLINGTON MILLION XXXVII (GI) on Saturday, August 10th.

The 2019 MUNIZ MEMORIAL HANDICAP (GII) winner at Fair Grounds Race Course will be granted an automatic berth (no fees) to the 2019 OLD FORESTER TURF CLASSIC (GI) May 4th at Churchill Downs and the 2019 ARLINGTON MILLION XXXVII (GI) August 10th. The winner of the 2019 OLD FORESTER TURF CLASSIC (GI) at Churchill Downs will also be granted an automatic berth (no fees) to the ARLINGTON MILLION XXXVII (GI).

The winner of the Group II PREMIO PRESIDENTE DELLA REPUBBLICA at Capannelle (May 19th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I PRIX D'ISPAHAN at Longchamp (May 26th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I TATTERSALLS GOLD CUP at The Curragh (May 26th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I CORAL-ECLIPSE at Sandown Park (July 13th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winner of the Group I GROSSER DALLMAYR-PREIS-BAYERISCHES ZUCHTRENKEN at Munich (July 28th) will have a "2019 FESTIVAL FREE PASS" to the ARLINGTON MILLION XXXVII (GI) with the entry and starting fees being waived.

The winners of the Group II PREMIO PRESIDENTE DELLA REPUBBLICA, Group I PRIX D'ISPAHAN, Group I TATTERSALLS GOLD CUP, Group I CORAL-ECLIPSE AND Group I GROSSER DALLMAYR-PREIS-BAYERISCHES ZUCHTRENKEN must be either either: an Early Nominee for the 2019 ARLINGTON MILLION XXXVII (GI) - \$300 on Saturday, May 18th or a Late Nomination - \$2,000 on Saturday, July 27th.

Officials of the INTERNATIONAL RACING BUREAU will contact the winning connections to provide more details concerning the "2019 FESTIVAL FREE PASS".

These nominations and all races are subject to the Rules and Regulations of the Illinois Racing Board. Entries to these stakes are received subject to the right of the track officials to refuse the entry or the acceptance of a transfer of any entry without notice to subscriber. The decision of race officials shall be final in all matters.

ARLINGTON INTERNATIONAL RACECOURSE agrees that BREEDERS' CUP LIMITED shall be entitled to request applicable racing regulatory authorities to conduct random out of competition testing on horses nominated to Challenge Races each year up to the date of the Challenge Race to which the horse was nominated and on horses that have won Challenge Races each year up to the date of the Breeders' Cup World Championships. Further, ARLINGTON INTERNATIONAL RACECOURSE agrees to cause its nomination and entry forms for the Challenge Races to reflect this provision so that owners of horses nominated to Challenge Races may agree to BREEDERS' CUP LIMITED's ability to request out of competition testing. In addition, ARLINGTON INTERNATIONAL RACECOURSE covenants to cause the conditions of the Challenge Races to include the requirement that any Furosemide (Lasix) administered to a horse competing in such races be administered in accordance with applicable regulations by an official veterinarian, the racing veterinarian or his/her designee, provided that any veterinarian or vet techs participating in the administration must be prohibited from working as private veterinarians or technicians on the ARLINGTON INTERNATIONAL RACECOURSE or with participating licensees.

In all stakes races, final entries for starters must be made through the entry box at time of closing of entries as designated by the Racing Secretary.

Winner or non-winner of a stated sum means winner or non-winner of a single race of that value to the first horse.

Horses penalized in a race shall not be entitled to any of the allowances in such race.

Horses not entitled to the first allowance in a race shall not be entitled to the second, and if not the second, then to no subsequent allowance.

ARLINGTON INTERNATIONAL RACECOURSE reserves the right to change the running date.

ARLINGTON INTERNATIONAL RACECOURSE reserves the right to cancel this event without notice, at any time prior to the actual running thereof, without any liability to them, but in such event return of the entrance money to subscriber shall be made.

The Racing Secretary shall determine the horse(s) that are entitled to the Southern Hemisphere scale of weights.

Any race may be started with or without a stall gate starting machine.

ARLINGTON INTERNATIONAL RACECOURSE may desire to televise and/or record (on film, file or tape) the race and the activities incident to it, and to broadcast, exhibit and/or exploit same by any means now or hereafter known. All entries are accepted only on the condition that ARLINGTON INTERNATIONAL RACECOURSE reserves the rights in connection with the aforementioned. The nominator hereby expressly and irrevocably waives and releases any rights he may have in any matters mentioned in this paragraph including without limitation, any claim to invasion of the right of privacy.

ARLINGTON INTERNATIONAL RACECOURSE reserves the right to transfer any turf stakes race to the Main Track in its sole discretion and where necessary at the alternate distance noted in the ARLINGTON INTERNATIONAL RACECOURSE Condition Book, or to change the distance of any of its stakes races.

In the event this stakes race is taken off the turf, it may be subject to downgrading upon review by the Graded Stakes Committee.

Two (2) horses having common ties through ownership cannot start to the exclusion of a single ownership interest.

Earnings as reported in the *Daily Racing Form* shall be used in determining the preference of horses based on earnings.

ARLINGTON INTERNATIONAL RACECOURSE has the option if a stakes race is part of a National Wagering Pool or Contractual Television Arrangement to adjust scratch time in order to fulfill the obligations of the National Wagering Pool.

If a race is part of a National Wagering Pool, or is a Contractual Television Arrangement, ARLINGTON INTERNATIONAL RACECOURSE reserves the right to alter the date of the stakes race by one day.

Horses for the ARLINGTON MILLION XXXVII (GI) must be pre-entered with a jockey by 12:00pm (CDT) on Friday, August 2, 2019, along with the payment of the Entry and Starting Fees.
 Starters for the ARLINGTON MILLION XXXVII (GI) will pass through the Entry Box on Tuesday, August 6, 2019.

ARLINGTON INTERNATIONAL RACECOURSE reserves the right, in its sole and absolute discretion to accept nominations which are not complete. The inclusion by ARLINGTON INTERNATIONAL RACECOURSE of a horse's name in the publicly released list of nominees for the 2019 ARLINGTON MILLION XXXVII (GI) shall constitute prima-facie evidence of the nomination and the ownership's liability for nomination fees.
