## 105th Running Of The American Derby (Grade III) \$150,000 Guaranteed

**FOR THREE-YEAR-OLDS** By subscription of \$100 each, which should accompany the nomination. A Supplementary Nomination of \$1,250 may be made on Wednesday, July 10, 2019, which includes entry and starting fees. Original nominees to pay \$400 to pass the entry box and an additional \$400 to start, with \$150,000 Guaranteed; after payment of 1% to all owners of horses finishing sixth through last, 60% to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. The entry and starting fees for the SECRETARIAT STAKES (GI) will be waived for any horse that finishes 1st, 2nd or 3rd in the AMERICAN DERBY (GIII) and enters and starts in the SECRETARIAT STAKES (GI) on Saturday, August 10, 2019. Weight: 126 lbs. Non-winners of \$60,000 once at one mile or over in 2019, allowed 3 lbs.; \$30,000 twice at one mile or over in 2019, 5 lbs.; \$30,000 once at one mile or over in 2019, 7 lbs. (Maiden, Claiming and Starter races not considered.) This event will be limited to fourteen (14) starters. (1st) Preference: winners or placed horses of Graded/Group Stakes (In Order of I-II-III); (2nd) Preference: Highweights; (3rd) Preference: winner of a sweepstakes; (4th) Preference: horses of equal weight will be Highest Total Earnings in 2019. Failure to draw into this race at time of entry cancels all fees with the exception of the nominating fee(s). Starters to be named through the entry box by usual time of closing. Two (2) horses having common ties through ownership cannot start to the exclusion of a single ownership interest. Trophy to the owner of the winner.
