**A HANDICAP FOR THREE-YEAR-OLDS AND UPWARD** (Illinois Registered, Conceived and/or Foaled). By subscription of \$75 each, which should accompany the nomination. A Supplementary Nomination of \$1,000 may be made by Saturday, July 17, 2019 no later than 3:00p.m., which includes entry and starting fees. Original nominees to pay \$300 to pass the entry box and an additional \$300 to start, with \$75,000 Added which includes \$25,000 for Illinois Conceived and Foaled (IB); after payment of 1% to all owners of horses finishing sixth through last, 60% of the remaining purse shall be paid to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. WEIGHTS: Saturday, July 13, 2019. This event will be limited to fourteen (14) starters. Preference will be Highweights (on the scale). \* Total earnings in 2019 will be used to determine the order of preference of horses assigned equal weight (on the scale). Failure to draw into this race at time of entry cancels all fees with the exception of the nominating fee(s). Starters to be named through the entry box by usual time of closing. Two (2) horses having common ties through ownership cannot start to the exclusion of a single ownership interest. Trophy to the owner of the winner.
